The Company is pleased to provide its members the facility of casting votes electronically ("remote e-voting"), through the e-voting services provided by National Securities Depository Limited ("NSDL").

The remote e-voting (e-voting from a place other than venue of the AGM) period begins on **Tuesday**, the 30th **July**, 2024 at 9:00 a.m. IST and ends on **Thursday**, the 1st **August**, 2024 at 5:00 p.m. IST. During this period, members of the Company, holding shares either in physical form or in dematerialized form as at the cut-off date i.e. **Friday**, the 26th **July**, 2024 may cast their vote electronically. The remote e-voting module shall be disabled by NSDL for voting thereafter.

The facility for casting votes electronically ("e-voting") shall also be made available at the AGM.
